An Aerodrome Reporting Officer is a critical member of the aerodrome management team.

An ARO is an operational specialist; they patrol runways, preserve security, and continuously monitor airspace for obstacles, navigational equipment and infrastructure—without their protective eye, intuition and action, runway safety may be compromised.



Entry to the aerodrome airside starts with the basic ARO course. From there you can advance to the ARO Skill Set AVISS00053 and continue your career pathway toward the Certificate III in Aviation (Aerodrome Operations) AVI30516. This entry-level three-day Aerodrome Reporting Officer course prepares you for work as an ARO and Works Safety Officer (WSO) at a regional airport or small country airstrip. Aerodrome Reporting Officers inspect critical areas of the airfield to ensure runways, taxiways, aircraft movement areas and airport infrastructure is safe for use. The course is based on the Australian Manual of Standards MOS Part 139-Aerodromes and is designed for anyone who wants to work as a reporting officer.

ARO training is also of benefit to management and staff who need to understand the regulations and technical aspects of aerodromes, and who are responsible for management systems and monitoring processes that keep their aerodrome compliant.

Our instructors will teach you how to:

- Conduct routine inspections of runways and aerodrome infrastructure;
- Report the condition of runways, navigational equipment, and facilities; and,
- Supervise maintenance workers.




Who can apply?

RPL Pre-requisites ARO Skill Set AVISS00053

If you have the following pre-requisites, you may apply for formal recognition of prior learning for the award of the ARO Skill Set.

- ARO with 12 months of operational experience at a registered or certified aerodrome
- ARO with 18 months of operational experience at an aerodrome other than certified or registered and 6 months of operational experience at a registered or certified aerodrome
- Government Inspector (Aerodromes) with 12 months of operational experience
- Department of Defence Member with 12 months of operational experience in aerodrome operations at a joint user aerodrome, or with 18 months of operational experience at an aerodrome other than certified or registered and 6 months of operational experience at a registered or certified aerodrome

There are pre-requisites for RPL pathway for the ARO Skill Set: you must have an Australian driver's licence and a permit to drive airside at any Australian aerodrome.

RPL pre-requisites Certificate III in Aviation (Aerodrome Operations) AVI30516

If you have the following pre-requisites, you may apply for formal recognition of prior learning for the award of the Certificate III in Aviation (Aerodrome Operations) AVI30516.

- ARO with 24 months of operational experience at a registered or certified aerodrome
- ARO with 30 months of operational experience at an aerodrome other than certified or registered and six months of operational experience at a registered or certified aerodrome
- Government Inspector (Aerodromes) with 18 months of operational experience
- Department of Defence Member with 18 months of operational experience in aerodrome operations at a joint user aerodrome, or with 24 months of operational experience at an aerodrome other than certified or registered and 6 months of operational experience at a registered or certified aerodrome

There are pre-requisites for RPL pathway for the Certificate III in Aviation (Aerodrome Operations): you must have an Australian driver's licence and a permit to drive airside at any Australian aerodrome



What do I need to do for RPL?

There are two parts to obtaining formal qualifications: *learning*, and then *assessing* your competence in what you have learned. You've done the first part. You have learned the skills and acquired knowledge and experience, so the only remaining task is for us to assess your competence.

There are six assessment tasks you need to complete—such as essays, assignments, interviews, and examinations, all of them loaded on our learning management system and written in the Student Workbook. The Skill Set has four assessment tasks.

You may choose one of two options for your assessment: option 1, complete the activities as written in the Student Workbook, or option 2, submit your own work.

Assessment Option 1

Coursework Assessment

The Student Workbook assessment pathway enables you to demonstrate your competence by completing coursework activities—such as assignments, interviews, and exams that are specifically related to the duties of an ARO. This pathway uses aerodrome-specific scenarios and case studies from registered, certified and other category aerodromes for the assessment tasks. In some activities, you may choose case studies or examples of your own.

ARO Skill Set

There are four assessment tasks to complete. The majority require a short form or essay answers using some sample industry templates and reports. You are asked for photographic or video evidence as well—such as a video of you inspecting, or a photograph of a particular item, along with your commentary about it—the condition of the wind indicator for example.

Certificate III in Aviation (Aerodrome Operations) There are six assessment tasks to complete. The

majority require a short form or essay answers using some sample industry templates and reports. You are asked for photographic or video evidence as well such as a video of you inspecting, or a photograph of a particular item, along with your commentary about it—the condition of the OLS for example.

Assessment Option 2

Evidence Portfolio Assessment

The Evidence Portfolio assessment pathway allows you to demonstrate your competence in a given subject by producing examples of your own work and submitting them for review—rather than the traditional approach of sitting exams or writing assignments.

There are six assessment tasks to complete for the certificate, and four for the Skill Set—how many you complete with your portfolio of evidence, and how many you complete through assessment option 1, is your choice. Your assessor will work with you to get sufficient evidence for each unit.

FAQs

What if I need a refresher before I do the assessment?

We all forget, and as time goes by we forget more. If you feel you are weak in a certain subject, and not confident to complete any of assessment streams, or if you are interested in reading more about the subject, you can update your knowledge before assessment using our self-study course material.

When you enrol, we will send you textbooks and online learning resources for all units in the course. The books are offered as a guide, for you to refresh your knowledge, to explore deeper into a subject and to keep and to refer to as you progress and develop as a leader and manager of aerodrome operations.

Then, when you are ready, you can complete the assessment activities with up-to-date knowledge and information.

Can I mix and match assessment streams?

Yes, you can select the assessment stream for each unit that is the best fit for you and your situation.

How much time do I have to complete the assessments?

You must complete and submit all assessment tasks within six months of enrolment.

How much time does it take to complete the assessments?

The time it takes to complete the certificate depends on your experience, knowledge of the subject matter and how much time you have to allocate to completing the activities.

An experienced professional with a comprehensive body of work collected from years of experience may submit an assessment portfolio that meets the performance criteria and be done in a week. Some, however, may choose to mix and match assessment options, taking their time to refresh their knowledge of individual subjects before attempting the activities, while powering through others by submitting examples of their previous work.

Each task has several activities for you to complete; the average is seven activities per assessment task. In most cases, if you allow a week for each assessment task, you will have more than enough time, so approximately six weeks.

How do I submit my assessments?

You can log-in to the Institute's learning management system, and submit your tasks there. You can work off-line with your paper Student Workbook if you prefer, and then copy and upload your assessments to the Institute, or you can send copies of your work by post, or email it to your assessor. However, we prefer you use our online system for all assessments because your work is kept safe in the one spot.

Can I do my assessments at the Institute?

Yes, you can book into an evaluation workshop and complete your assessments at the Institute in Brisbane. We assess different units at each workshop, and they run throughout the year. Please check our website for dates and units to find a workshop that best suits you.
